Deutschland schafft sich ab Thilo Sarrazin,2025-01-20 Deutschland schafft sich ab löste 2010 bei seinem Erscheinen eine heftige gesellschaftspolitische Debatte aus. Es gab Versuche, den Inhalt zu skandalisieren, den Autor moralisch in die Ecke zu stellen und die inhaltlichen Argumente, die das Buch tragen, lächerlich zu machen. Von den Vorschlägen zur Abhilfe, die er in dem Buch machte, hat die deutsche Politik wenig bis gar nichts umgesetzt. Der Originaltext von 2010 wird noch in Jahrzehnten zeigen, was man hätte erkennen können, wenn man gewollt hätte, und was man hätte ändern können, wenn man die Ehrlichkeit und die Kraft dazu gefunden hätte. Er bleibt deshalb unverändert. Bei der jetzt vorgelegten Neuausgabe sind Thilo Sarrazins Kommentierungen und Ergänzungen in den ursprünglichen Originaltext eingebettet. So kann der Leser jeweils erkennen, wo es neue für die Analyse relevante Fakten gibt, bzw. wo sich Sarrazins Einschätzungen geändert haben. In der Summe wird so der Inhalt des Buches noch viel explosiver, als er es 2010 war.

Doch auch schon vor dem Erscheinen seines Buches ist Sarrazin mit polarisierenden Aussagen in den Medien präsent. Zwölf Jahre zuvor hielt der Schriftsteller Martin Walser in der Frankfurter Paulskirche eine Rede bei der Verleihung des Friedenspreises des deutschen Buchhandels, in der er sich kritisch zum Umgang mit der Holocaust-Erinnerung äußerte. Diese Rede löste ebenfalls eine Debatte aus, die in den Feuilletons der deutschen Zeitungen ausgetragen wurde, in der Ignatz Bubis, damaliger Vorsitzender des Zentralrates der Juden in Deutschland, sein härtester Gegner war. Die aktuellere Debatte um Thilo Sarrazin soll in dieser Arbeit im Vordergrund stehen. Bereits vor Sarrazin wiesen andere auf integrationspolitische Probleme in Deutschland hin, zum Beispiel Giovanni die Lorenzo, der Herausgeber der Wochenzeitung DIE ZEIT, im Jahre 2004, Rolf Stolz in Deutschland, deine Zuwanderer aus dem Jahr 2002 oder Hans-Hermann Gockel 2006 in Die überstrapazierte Nation. Allerdings lösten sie nicht annähernd die gleichen Reaktionen in Öffentlichkeit und Politik aus, wie Thilo Sarrazin. Warum waren die Reaktionen

bei ihm anders? Wieso wurde er gehört und seine Vorredner nicht? Im Verlauf dieser Arbeit soll die Kontroverse rund um Thilo Sarrazin dargelegt und analysiert werden. Die Walser-Bubis Debatte aus dem Jahr 1998 ist etwas kompakter und wird in einem nächsten Schritt zum Vergleich mit der Sarrazin-Debatte herangez

We Are All Migrants Jan Plamper, 2023-03-23 In 2015, Germany agreed to accept a million Syrian refugees. Stefan Wolpe and the Avant-Garde Diaspora Brigid Cohen, 2012-09-13 The German-Jewish émigré composer Stefan Wolpe was a vital figure in the history of modernism, with affiliations ranging from the Bauhaus, Berlin agitprop and the kibbutz movement to bebop, Abstract Expressionism and Black Mountain College. This is the first full-length study of this often overlooked composer, launched from the standpoint of the mass migrations that have defined recent times. Drawing on over 2000 pages of unpublished documents, Cohen explores how avant-garde communities across three continents adapted to situations of extreme cultural and physical dislocation. A conjurer of unexpected cultural connections, Wolpe serves as an entry-point to the utopian art worlds of Weimar-era Germany, pacifist movements in 1930s Palestine and vibrant art and

The German New Right Jay Julian Rosellini,2020-03-01 Contemporary Germany is a modern industrial democracy admired throughout the world. Many Germans believe that they live in the 'best Germany' that has ever existed. Yet there are dissenting voices: individuals and groups that reject cosmopolitanism, globalization and multiculturalism, and yearn for the more homogeneous country of earlier times. They are part of a global movement, often characterized as populist, that values tradition over innovation or constant change. In Germany, such people are routinely portrayed as reactionary or even neofascist. The present study seeks to provide a portrait of these individuals and their organizations. Very little has been written in English about the cultural figures who play a role in this movement. When the political side is discussed--whether in its manifestation as a party (the Alternative for Germany) or a citizens' group (PEGIDA)--the cultural dimension is usually ignored. Jay Julian Rosellini places the so-called New Right in the context of currents in German culture and history that differ from those in other countries. With Germany the dominant country in the European Union, economically and politically, this volume offers an essential view of its current conditions, future prospects and political particularities.

Immigrant Youth, Hip Hop, and Online Games Barbara Franz, 2015-08-13 Anti-Muslim racism with its attendant xenophobia and (the fear of) Salafist hostility are two of the most essential problems facing Europe today. Both result from the enormous failure of the continent's integration policies, which have either insisted on immigrants' rigid assimilation or left immigrants to fend for themselves. This book radically breaks with contemporary approaches to immigrant assimilation and integration. Instead it examines non-institutional approaches that facilitate immigrant inclusion through the examples of three alternative small-scale projects that have impacted the lives of urban working-class youth, specifically with secondgeneration immigrant roots, in Vienna, Austria. These projects involve online gaming, hip hop as an art form, and social work as emancipatory pedagogic practice (commonly referred to as street work). This book investigates working-class teenagers' social networks and describes an online game designed to provide a platform for interaction between non-immigrant and immigrant youth who usually either do not interact or display prejudice when they engage each other. Hip hop can provide both a necessary outlet for alienated youth to articulate their frustrations and a highly effective tool for transforming inclusion conflicts. Social work with marginalized youth is crucial for successful inclusion. Specifically individual support in small-scale settings provides a unique opportunity to open up spaces for discouraged and disaffected teenagers to gain selfworth and dignity. While the book focuses on identity formation and the teenagers' agency, it argues that only projects that include both "newcomer" and "native" can aid in overcoming exclusionary attitudes and policies, eventually allowing some form of social bonding to take place.

The Making and Breaking of Minds: How social interactions shape the human mind Isabella Sarto-Jackson, 2022-04-05 The human brain has a truly remarkable capacity. It reorganizes itself, flexibly adjusting to fluctuating environmental conditions - a process called neuroplasticity. Neuroplasticity provides the basis for wide-ranging learning and memory processes that are particularly profuse during childhood and adolescence. At the same time, the exceptional malleability of the developing brain leaves it highly vulnerable to negative impact from the surroundings. Abusive or neglecting social environments, as well as socioeconomic deprivation and poverty, cause toxic stress and complex traumas that can severely compromise cognitive development, emotional processing, self-perception, and executive brain functions. The neurophysiological changes entailed impair emotional regulation, lead to heightened anxiety, and afflict attachment and the formation of social bonds. Neuroplastic changes following severely adverse experiences are not something that a person grows out of and gets over. These experiences alter the neurobiological and biochemical makeup and cause people to live in an emotionally relabeled world in which the evaluation of any social cue, their behavior, cognition, and state of mind are biased towards the negative. Even more worrying, detrimental neurophysiological consequences are not limited to the traumatized individual but are often transmitted to subsequent generations through a process of social niche construction, thereby creating a vicious cycle. Thus, the making and breaking forces of the brain are epitomized by parents, alloparents, peers, and our socioeconomic niche. This book expounds on the formative role that the social environment plays in healthy brain development, especially during infancy, childhood, and adolescence. Based on scientific findings, the book advocates for bold measures and responsible stewardship to combat child abuse, maltreatment, and child poverty. By bringing together insights from neuroscience, evolutionary biology, and social education work, it lays out a fact-based, transdisciplinary endeavor that aims at rising to the societal challenge of providing a rewarding perspective to youth at risk. It will be a valuable resource for academics from social education, pedagogy, cognitive science, neuroscience, as well as professionals in the fields of social work, pedagogy, education, child welfare.
